Information We Collect

1. Personal Information

For a better experience while using our Service, we may request certain personally identifiable information, including but not limited to:

Log Data

If an error occurs while using the Service, we may collect data sent by your device ("Log Data"). This may include:

- IP address
- Device name

- App configuration at the time of the error
- Timestamp of the issue
- Other diagnostic information

This information is used for troubleshooting, analytics, and improving the stability of the Service.
